## President's Message

See! I did learn something from the International Convention. During the meeting last night when some of the members became somewhat loud, boisterous and virtually out of control; I issued the above statement and - my gracious, you could have heard a "pin drop". Yes sir, picked that one up during one of the House of Delegates sessions - and it works!

First let me thank the club for your support that enabled me to attend the

convention in San Antonio. The convention proved to be a great learning experience and the River Walk, the Market and San Antonio as a whole was neat place. Now let me bore you with some of the results.



*Alamo Attention-getter*

The positions of International President (won by **Dave Curry**) and President-Elect (won by **Donald Canady**) were uncontested and approved by a voice vote.

**Paul Palazzolo** of Illinois defeated **Peter Mihelich** of Missouri for the position of International Vice President.

**Bascom Allen, Sr.** of Mississippi, **Randolph Delay** of Texas and **Bernard Knott** of WV were elected as International Trustees.

Seventeen Amendments and one Resolution were brought before the House of Delegates and I will comment on the more significant ones (Full texts of all the proposed amendments can be found under "K-News on the International Website). I was both

surprised and pleased that the House was not a rubber stamp to the International Board and was ready to reject and/or amend those amendments recommended by them.

#1 To allow Kiwanis the flexibility to create and test new forms of membership and new ways to participate in Kiwanis service, consistent with the Objects of Kiwanis, on a limited basis. While this was passed it was amended to require that the Executive Director make an annual report as to the effectiveness of any such Board Action taken.

#2 To move the duties of the Chief Executive Officer in charge of day-to-day operations from the International President to the Executive Director. Amended and passed.

#4 Create a new classification of "shared active Membership". This would have allowed both husband and wife to be members of the same club but pay only one fee for membership. -Defeated

#6 To change the deadline for submission of proposed amendments and resolutions from April 1 to January 15 to allow more time for consideration and review. Following debate was amended to February 15 and passed.

#9 To require a minimum period of one year and one day between International Board service as a Trustee and the announcement of candidacy for a higher office, and to allow a district to have one Trustee and one higher officer on the International Board at the same time. There was much debate about this amendment which appeared to impugn the integrity of members of the International Board (implication that decisions would be made on the personal ambitions of the sitting board member rather than on "what was right". - Defeated

#11 To require clubs to offer members the option to vote by mail (absentee ballot) on club matters. Failed.

#14 Require a Majority vote to approve new provisions to the International Bylaws. This was Replaced by the language in Amendment #15 which requires a 2/3 vote to add new amendments and then was passed.

Resolution passed that Kiwanis International supports exploring collaboration with Rotary International, Lions Club International and Optimist International on ways to serve the needs of Children.

Again this was a true learning experience where I was able to see the political side of Kiwanis but also learn about potential new ideas and projects (which I am sharing with **President-Elect Jay** and committee members) and enjoy the association with members of our organization from across the world. Now let me offer you the opportunity to experience something similar.

Let me invite you, no, encourage you to attend the 89th **Capital District Convention** in Rockville MD August 18th and 19th. You will not only learn more about being more effective in your Kiwanis position but also share your ideas and interests with Kiwanians across the District.

Commercial Site Design of Raleigh, N.C. recently filed a site plan with the Chesterfield County planning department for a new full service coffee shop to be located on the southeast corner of West Hundred Rd. and Jefferson Davis Hwy.

"The existing building on the site, which once housed Scrubs and was built for First Virginia Bank, will be torn down to make way for the new Starbucks. The building will consist of approximately 1,850 square feet and include interior service, outdoor seating, and a drive-thru."
