ORIGINS AND HISTORY

- 1915 Kiwanis Club of Detroit as a professional organization
- 1916 In Cleveland - founding clubs unified into The National Kiwanis Club
- 1924 Headquartered in Chicago, Kiwanis adopts six permanent Objects
- 1961 Kiwanis become an International Organization
- 1982 Kiwanis International moves to present home site in Indianapolis, IN.
- 1987 Kiwanis becomes Co-ed - Kiwanis International Convention

PRESENT DAY

- Over 280,000 members, located in 96 countries
- 48 districts worldwide, 30 in North America with more than 8,400 clubs
